Attorneys in the Real Estate Practice Group also routinely work with the attorneys in the Financial Transactions and Regulations Practice Group on matters related to commercial loans.

When the client's transaction involves property located outside of North Carolina, whether inside or outside of the United States, we have the ability to associate counsel in the geographical area involved and to work with the local attorney to ensure the client receives proper representation in that jurisdiction and in the transaction.
