## REPRESENTATIVE CASES

- Estate planning for modest to large estate clients. Recent plans have included:
  - Complex beneficiary schemes including charitable giving plans;
  - Stand-alone or backup supplemental needs trust provisions to protect beneficiaries who participate in needs-based aid programs; and
  - Provisions to ensure compliance with and enforcement of marital settlement agreements
- Representative trust and estate administration matters have included:
  - matters that had real estate (ranging from residential properties to apartment complexes, to farm land) that required being sold or transferred from the estates
  - matters that had unusual assets to be managed (e.g. art collections, coins, guns, doll collections, old private bank stocks)
  - estates with holographic wills, wills that were found after the estate was open, and where there were will contests
- Represented all sides of guardianship actions, including having served as *guardian ad litem* and having represented the respondent. These matters have ranged from simple and/or consented to guardianships to contested guardianships.
- As a mediator for a court-run foreclosure mediation program, she has mediated cases with results ranging from home retention to the graceful negotiation of non-retention options.
