RECENT DEALS/CASES

- Won a breach of contract and tortious interference case in Kankakee Circuit Court during a bench trial on a directed finding. Verdict affirmed on appeal in 2018.
- Obtained a temporary restraining order on behalf of a pipette supply, repair, and calibration company after it was discovered that former employees were engaged in unfair competition.
- Defended and won a bench trial on behalf of a national corporation involving an invasion of privacy claim. He has recently won three Title VII cases on summary judgment in the U.S. District Court, N.D. Ill. in 2014, 2017, and 2018.
- Won a 5 day jury trial defending an employer in Joliet, IL against whistleblower and retaliation claims. Jurors polled after the trial pointed to Mr. Molho’s demeanor and presentation as a key to the victory.
