Experienced in many types of cases

We have worked with clients in a broad range of cases, helping clients receive compensation for negligence and harm that resulted in brain injury, paralysis, long-term disability, and wrongful death.

We routinely handle cases involving:

- **Auto accidents:** After you've been involved in an accident, it might seem easy to sign the first piece of paper an insurance company hands you. However, it may be in your best interest to first find an attorney to help you understand all your rights and options.
- **Truck/18-wheeler accidents:** Our highways and roads are crowded with more vehicles than ever before. This congestion can contribute to a greater risk of being involved in an accident with a big truck, 18-wheeler, tractor trailer, or other large vehicle. From a legal standpoint, these accidents are often different than routine car accidents, so you should understand your rights.

- **Medical malpractice:** All of us trust health care facilities and physicians with sensitive and vital health care matters. The consequences of negligence can be severe for individuals and families. If you think a mistake was made in your care or the care of a loved one, call an attorney.
- **Premises liability:** If you were injured on someone else's property you should know your rights. We can investigate the circumstances and explain your choices. You may be owed compensation for your injuries.
- **Nursing home injury and death claims:** Facilities that care for the elderly and disabled, including rest homes and assisted living facilities, must uphold specific standards of care. If they fail to do so, injury and death can sometimes result. When these tragic events occur, we know how to navigate the management and regulatory agencies to get the answers that your loved one deserves.
- **Product liability cases:** If you became ill, were injured, or were otherwise harmed as a result of using a product that should have been safe, call a lawyer. From everyday consumer products to drugs and medical devices, manufacturers have legal obligations related to the safety of their products.
- **Other accidents and injuries:** There are many other circumstances that can lead to serious harm. These include: Firearm injuries and death, spring break and vacation accidents, dog bites, other animal attacks, and more. If you or a loved one has been hurt, you may be due compensation.
