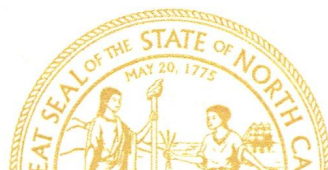

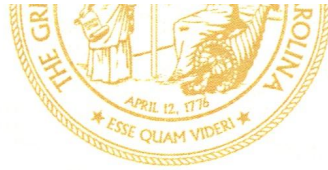

**WHEREAS**, paralegals assist in the practice of law by conducting research, drafting essential documents, maintaining timely correspondence, and contributing their legal knowledge to the benefit of the profession and our state; and

**WHEREAS**, paralegals improve cost, efficiency, case management, client representation, and case flow, and advance the legal profession through continued training and education; and


**WHEREAS**, Paralegal Day provides an opportunity to recognize paralegals for their skill and proficiency carrying out significant legal work under the lawful supervision of a licensed attorney; and
