Milestones

- Successfully defended an employer from an employee's allegation that his lung cancer was caused by low level gamma radiation exposure during his employment.

- Successfully defended, in Guilford County Superior Court, an attempt to extinguish a workers' compensation lien on an employee's settlement from a third-party tortfeasor, thereby reducing workers' compensation costs for the employer.
